## About Stony Brook Eastern Long Island Hospital

As part of Stony Brook Medicine, Stony Brook Eastern Long Island Hospital (SBELIH) combines the best in academic and community medicine, improving access to advanced medical care for residents of the North Fork and Shelter Island. With 70 beds, SBELIH is Suffolk County's first hospital, serving all of Suffolk County since 1905.

SBELIH provides care to 25,000 year-round residents and expanding to 60,000 summer residents with comprehensive healthcare solutions, including behavioral health, medical-surgical, orthopaedics and general surgery, wound care, interventional pain management and gastroenterology, advanced ambulatory care, diagnostic laboratory and radiology services, and physical therapy services. The hospital is also a clinical campus and training site for Stony Brook Medicine, with its first SBELIH Psychiatry resident having graduated in 2022.

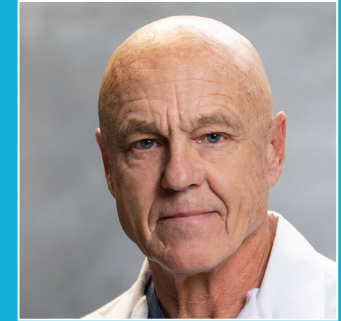

Over the past year, Stony Brook Eastern Long Island Hospital (SBELIH) has seen remarkable growth and progress.

For more than 119 years, the ELIH Auxiliary has dedicated itself to ensuring that the residents and visitors of the North Fork and Shelter Island have ready access to the highest quality healthcare.

In 2023, our all-volunteer group of 100 passionate community members provided close to 14,000 hours of service with in-hospital volunteers donating 1,299 hours of service along with celebrating 65 years of in-Hospital volunteering, the Opportunity Shop volunteers donating 8,850 hours of service, and the balance of hours of service donated by our wonderful Auxiliary Executive Board, through special fundraising projects undertaken by the Membership/Special Projects Division such as Ladies Day on the Links and the Italian Night Dinner and two annual Auxiliary fundraisers-the Dream Green Extravaganza and the Car/Cash Giveaway.

Our motivation today remains the same, to ensure that our local community hospital, Stony Brook Eastern Island Hospital, continues to thrive and has the resources needed to add innovative technologies and care programs.

I am proud to say that 2023 was another banner fundraising year for the ELIH Auxiliary. Much of last year's success is due to the hard-working volunteers at the ELIH Opportunity Shop, a thrift shop in Greenport Village. Through their efforts, as well as Membership/Special Events projects and two major fundraising events, we donated \$572,000 to the Hospital!

The total donations from the Auxiliary to the ELIH Foundation were \$330,000 in unrestricted gifts, \$39,000 from the Car/Cash Giveaway, \$104,500 from the Dream Green Extravaganza, \$58,000 for new Med/Surg beds, \$30,000 for the doctors lounge update, \$2,500 was donated to support an employee funded project for a new Hospital pergola and \$8,000 for our wonderful Employees' holiday party. In addition to the \$572,000, \$900 in Memorial donations were made to honor Auxilians, and, the Auxiliary continued to fund 100% of the almost \$10,000 cost to provide in-Hospital cable TV service to our patients. Over the years, the Auxiliary has raised over \$12.5 million for our Hospital.

I am grateful to the many talented volunteers and members who generously give their time to the ELIH Auxiliary. Your talent, ingenuity, and dedication inspire me every day!
