As part of Stony Brook Medicine, Stony Brook Eastern Long Island Hospital (SBELIH) combines the best in academic and community medicine, improving access to advanced medical care for residents of the North Fork and Shelter Island. With 70 beds, SBELIH is Suffolk County's first hospital, serving all of Suffolk County since 1905.

SBELIH provides care to 25,000 year-round residents, and expands to 60,000 summer residents, with comprehensive healthcare solutions, including behavioral health, medical-surgical, orthopedics and general surgery, wound care, interventional pain management, gastroenterology, advanced ambulatory care, diagnostic laboratory and radiology services, and physical therapy services. The hospital is also a clinical campus and training site for Stony Brook Medicine, with its first SBELIH Psychiatry resident having graduated in 2022.

Celebrating 120 years as Suffolk County's first hospital, Stony Brook Eastern Long Island Hospital (SBELIH) remains a cornerstone of the North Fork and Shelter Island communities. More than just a hospital, SBELIH fuels the local economy with hundreds of jobs and a \$25 million annual impact, while delivering compassionate, high-quality care that generations have relied on.

We've made significant strides toward becoming a certified Primary Stroke Center. This important milestone will bring advanced, life-saving stroke care directly to our region. In recognition of the exceptional teamwork that makes this possible, we introduced two new honors. The inaugural Krystal Clear Award was presented to a staff member whose quick action saved a colleague's life during a stroke emergency. At the same event, Life Saver Awards recognized 27 team members across seven departments who responded to the same stroke emergency, demonstrating how every role at

SBELIH contributes to extraordinary patient care.

SBELIH continues to lead in behavioral health, offering the only fully integrated inpatient detoxification, rehabilitation, psychiatric, and medical services on Long Island. Our infection prevention record remains one of the best in the state, with consistently zero hospital-acquired infections. State and federal grants supported major initiatives, including the expansion of Quannacut and the development of new recovery homes. This work is made possible in part by the unwavering support of our ELIH Auxiliary. Thanks to their fundraising and continued philanthropic efforts, gifting the hospital with a record-breaking over \$600,000 donation in 2024, we are well-positioned to deliver on our promise of high-quality, compassionate care.

We proudly marked a leadership milestone this year, extending a warm welcome to Dr. Alison Madden as our

new Chief Medical Officer. Her arrival follows the retirement of Dr. Lloyd Simon, who dedicated 42 years of extraordinary service to SBELIH.

In partnership with Community Action for Social Justice and local businesses, we've expanded the Narcan Rescue Station program throughout both the North and South Forks, enhancing access to life-saving overdose prevention tools. Through our collaboration with CAST, another community-based program, we co-host an annual health fair and ensure patients discharged from the hospital continue to receive vital nutrition via CAST's local food pantry. Our association with Food Rescue US—North Fork has also been recognized by HANYS for its powerful impact on hunger relief and sustainability across the region.

MESSAGE FROM THE ELIH AUXILIARY

For more than 120 years, the ELIH Auxiliary has dedicated itself to ensuring that the residents and visitors of the North Fork and Shelter Island have ready access to the highest quality healthcare.

In 2024, our all-volunteer group of 100 passionate community members provided over 14,500 hours of service in total. This included 1,310 hours in-hospital and 9,025 at the Opportunity Shop Thrift Store. The balance of hours of service was donated by our wonderful ELIH Auxiliary Executive Board through special fundraising projects undertaken by the Membership/Special Projects Division such as Ladies Day on the Links, the Italian Night Dinner and two annual ELIH Auxiliary fundraisers - the Dream Green Extravaganza and the Car/Cash Giveaway.

Our motivation today remains the same as it was in 1905, to ensure that our local community hospital, Stony Brook Eastern Island Hospital, continues to thrive and has the resources needed to add innovative technologies and care programs.

I am proud to say that 2024 was another record-breaking fundraising year for the ELIH Auxiliary. Much of last year's success is due to the hard-working volunteers at the ELIH Opportunity Shop in Greenport Village. Through their efforts, as well as Membership/Special Events projects and two major fundraising events, we donated \$600,000 to the hospital!

The total donations from the Auxiliary to the ELIH Foundation were \$328,500 in unrestricted gifts, \$39,000 from the Car/Cash Giveaway, \$116,000 from the Dream Green Extravaganza, \$10,000 for 2 North Mattresses, \$93,500 for a new ASU Sterilizer, \$5,000 to the Social Worker Education Fund in Memory of outstanding Auxiliary Nora Busch and \$8,000 for our wonderful Employees' holiday party. In addition to the \$600,000, \$300 in memorial donations were made to honor Auxilians, and the ELIH Auxiliary continued to fund 100% of the almost \$10,000 cost to provide in-hospital cable TV service to our patients. Over the years, the Auxiliary has raised in excess of \$13 million for our hospital.

I am grateful to the many talented volunteers and members who generously give their time to the ELIH Auxiliary. Your talent, ingenuity, and dedication inspire me every day!
